Purple Heart County



County Executive Dennis Gannon read a proclamation designating Jefferson County as a Purple Heart County during the July 8, 2024, County Council Meeting. The County Executive and members of the County Council signed the proclamation. Along with the proclamation, signage designating Jefferson County as a Purple Heart County will be placed along various state-maintained and county-maintained roads in Jefferson County.

Originally designed as the Badge of Military Merit by General George Washington in 1782, the Purple Heart is the oldest military award still in circulation today. It is the first medal or award for service in America that is offered to US Armed Forces members who have suffered injuries or made the ultimate sacrifice while engaged in conflict with a country that has been officially designated as the enemy of the US.

The Military Order of the Purple Heart's objectives are to support legislative efforts, encourage patriotism, create a friendly environment among combat wounded veteran members and their families, and, above all, ensure that we never forget.

"We appreciate the sacrifices our Purple Heart recipients made in defending our freedoms," said County Executive Dennis Gannon. It is important that we acknowledge them for their courage and show them the honor and support they have earned.



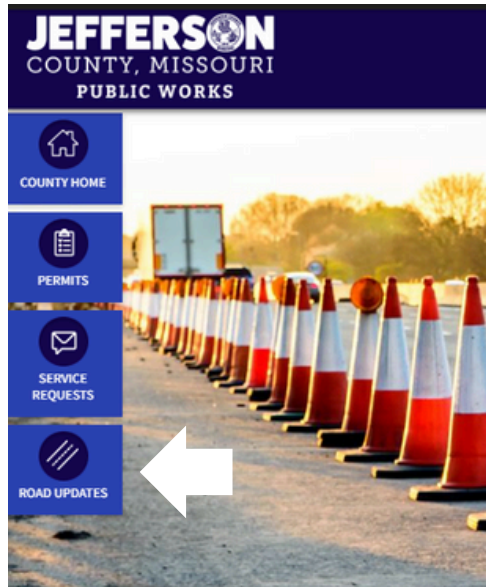

The County is currently engaged in multiple road development projects that are in various stages of execution. We prioritize the regular monitoring and maintenance of our roadways and the surrounding right-of-way, reflecting our dedication to improving transportation conditions for all residents and visitors in Jefferson County.

The Walk Bike Master Plan is Moving Forward

These sessions brought together a diverse group of participants, each contributing unique perspectives and suggestions that highlighted the needs and desires for better walking and biking experiences.

On August 7th, an advisory panel met to discuss the findings and data that had been gathered up to that date. This meeting was an important opportunity for the panel to review all the relevant information and share insights on what had been discovered so far.

Additionally, on August 15th, the Pevely Days celebration featured a public engagement event that provided an excellent opportunity for community members to participate and voice their opinions.

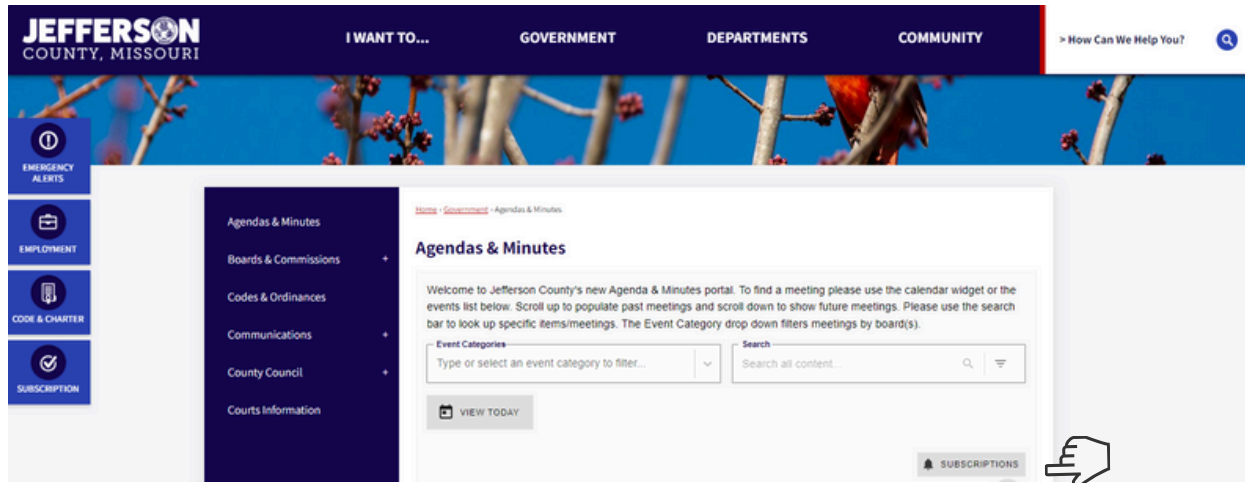

AMM is Live

On Monday, August 12, the County Council kicked off their first meeting with the new Agenda and Meeting Management system, signaling a new chapter in their approach to organizing and running their meetings. This innovative system streamlines the process, allowing for a more efficient way to manage meetings and ensuring that all relevant information is conveniently located in one place for everyone involved.

The introduction of this system is a game changer for the County Council, as it enhances transparency and accessibility for both council members and the public. With everything centralized, it not only simplifies the preparation for meetings but also makes it easier for attendees to stay informed and engaged with the proceedings.

GIS Updates

Get ready for some significant upgrades to our Geographic Information System (GIS)! Over the next few months, the system will undergo a major transformation, moving from outdated physical servers to modern virtual machines as well as a major ESRI software upgrade.

Why the Change?

Currently, GIS operates on two physical servers housed at the REJIS office. However, with advancements in technology and a significant new version of the ESRI software, it's been recommended to transition to virtual machines (software-based resources that run applications without relying on physical hardware). This change will not only keep us up to date but also enhance the performance and capabilities of our GIS. Many ESRI applications and processing currently used will be depreciated (no longer supported) without this software upgrade and requires a mandatory migration to provide this GIS technology to all users.

What Does This Mean for You?

County offices currently use internal GIS Viewers for data search and visualization. These tools, along with data editing performed by the Assessor's office's mapping division, the planning division in County Services, and the GIS division, will all be affected by the upgrade. The GIS division, which maintains the system and collaborates with all departments, will be tasked with recreating all internal GIS Viewers and applications post-upgrade.

One of the most popular tools, the [Property Viewer](#), along with other [GIS applications](#) available on the County Website (found under Home > Departments > Assessor > GIS Data/Maps), will be rebuilt. This upgrade is an opportunity to create a more robust application system, enhanced tools, and new GIS applications for both county employees and the public.

Stormwater Runoff



Contaminants include:

- Cigarette butts, litter, and other debris from sidewalks
- Motor oil poured into storm sewers
- Pet wastes
- Settled air pollutants
- Yard wastes, pesticides and fertilizers from lawn care
- Sediments or chemicals

Why has stormwater runoff become such a problem?

Urbanization, increasing commercial and residential development have a great impact on local water resources. More impervious surfaces (roads, rooftops, parking lots and other hard surfaces that do not allow stormwater to soak into the ground) increase the rate of stormwater runoff. This means a greater volume of water carrying pollution into surface waters and less water soaking into the ground.

Where does stormwater go?

- Stormwater flows directly into our rivers, lakes, streams and the ocean or into a stormwater system through a storm drain which are located in parking lots and along the curbs of roadways. The grate that prevents larger objects from flowing into the storm sewer system is called a catch basin. Once below ground, the stormwater flows through pipes, which lead to an outfall where the stormwater usually enters a stream, river or lake.
- In some areas, the outfall may lead to a stormwater management basin. These basins control the flow and improve the quality of stormwater, depending on how they are designed. They can also recharge groundwater systems

Less water soaking into the ground also lowers ground water levels, which can dry up streams and hurt stream ecosystems, and can reduce the supply of well water.

What are some simple changes I can make to protect our waters?

- Never dump contaminants (listed above) into the roadway or stormwater catch basins.
- Landscape your yard to minimize rainwater runoff and divert rain from paved surfaces onto grass to permit gradual infiltration.
- Preserve the established trees in your neighborhood, which help minimize the damage caused by surface runoff. Choose the appropriate plants, shrubs and trees for the soil in your yard; do not select plants that need lots of watering, which increases surface runoff.
- Consult your local nursery or your county's Rutgers Cooperative Research and Extension office for advice on which plants, shrubs and trees will grow well in your yard.
- Excavation or grading with no erosion control measures in place to protect the waterways and or adjoining property.

Rain Events That Exceed Stormwater Systems Capabilities:

Flash floods are the most dangerous kind of floods, because they combine the destructive power of a flood with incredible speed. Flash floods occur when heavy rainfall exceeds the ability of the ground to absorb it. They also occur when water fills normally dry creeks or streams or enough water accumulates for streams to overtop their banks, causing rapid rises of water in a short amount of time. They can happen within minutes of the causative rainfall, limiting the time available to warn and protect the public.

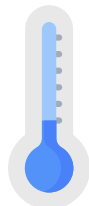
Jefferson County Parks and Recreation Department will be sponsoring its annual Christmas Tree Recycling Program from December 26, 2024, through January 20, 2025.

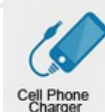
