High Ridge Boulevard Pedestrian Sidewalk

On October 10th, a ceremonial ribbon-cutting event took place to mark the official inauguration of the newly constructed pedestrian sidewalk and the enhanced roadways along High Ridge Boulevard. This significant occasion represented the successful project led by Jason Jonas, the Director of Public Works for Jefferson County, in collaboration with his team. Their efforts were primarily aimed at enhancing pedestrian safety and accessibility within the community.

This project's completion is a result of the hard work and devotion of everyone involved, and it reflects a larger commitment to enhancing infrastructure and making pedestrian traffic safer. In addition to making it easier for people to move around on foot. The improvements also boost the neighborhood's general livability and connection.



The ribbon-cutting demonstrated the community's commitment to improving infrastructure for its citizens. Many community residents and stakeholders gathered to celebrate this important milestone, and County Executive Dennis Gannon and County Councilman Brian Haskins welcomed them all.

The event attracted a remarkable number of attendees, exceeding 200 individuals. This significant participation reflects a strong interest and engagement from the community, highlighting the event's importance and appeal.

In addition to the informative presentations, the Open House featured a pop-up demonstration that allowed members of the public to visualize the proposed changes in a practical setting.

Public Works Completed 1,748 Citizen Service Requests in 2024



For the year 2024, the Public Works Department successfully addressed a total of 6,933 work orders submitted internally. This comprehensive effort included the fulfillment of 402 service requests specifically related to Stormwater management, alongside 1,346 service requests pertaining to Highway and Traffic operations.

The wide range of services offered by the department demonstrates its dedication to serving the community and reflects a proactive approach to maintaining Jefferson County's roadways, bridges and infrastructure. Real Property Tax Credit for Seniors

The Jefferson County Real Property Tax Credit for Seniors was established in response to enabling legislation from the Missouri General Assembly and enacted on February 15, 2024, by Jefferson County under Ordinance #24-0132.

Starting March 1st, applications for the tax credit will be available to the public on Jefferson County's website and at the offices of the County Clerk and County Collector.

One of the qualifications for this tax credit is that applicants must be at least 62 years old as of January 1, 2024. For other qualifications, please see the Collector's webpage.

In addition to the qualifications and timeframe for applying, there is also a list of frequently asked questions. The County is committed to making this process as user friendly as possible for the seniors of Jefferson County.

Real Estate & Personal Property taxes became delinquent on January 1st. Per State Statute, Interest & penalty accrue monthly, and the interest increases 2% a month for 9 months of the year.

Payments may be made in person at the Collector's office, online at www.jeffcomo.org (Collector's page), through the mail or by dropping in the drop box on the front of the Administration Building, 729 Maple Street, Hillsboro, MO 63050.

2025 Assessments Have Been Mailed

The Jefferson County Assessor's Office mailed hard copies of personal property assessment lists the first week of January 2025.

Per Missouri State Statutes, assessment lists are to be returned to the Assessor's office before May 1, 2025, to avoid late penalty.

Taxpayers still have the option to E-File their 2025 Assessment List. When you receive your 2025 Assessment list it will provide a link to the E-File website, account number and PIN.

Civic Development Launch

In August of 2024, we went Live with CivicPlus's Agenda and Meeting Management software which includes many enhancements to the agenda/meetings platform and has received significant positive feedback. As we are continuing to improve processes for business with our citizens and workflow for our employees, we anticipate launching CivicPlus's Civic Development software in the first half of 2025.

Civic Development, previously known as CivicGov, is a multi-module platform including permitting, licensing, Code Enforcement and Planning & Zoning.

The permitting and licensing modules will be the first to be implemented and will allow citizens to create an account to apply for liquor licenses, contractor licenses, and permits.

Citizens will also be able to pay and receive your license/permit online. Additionally, citizens will be able to track the progress of their applications throughout the process. This will allow for quicker processing, citizens to be more informed and reduction in human error.

Adoption

Jefferson County Animal Control requires adopters to be 18 years old and to meet the animal in person to ensure a perfect match for their household, with the option to bring along other pets to observe their interaction.

The adoption process is 20 minutes long and involves meeting the animal, filling out the Adoption Application, and working with the Rescue Coordinator. All animals must be spayed or neutered according to state laws. Adoptions typically occur within two to three business days, ensuring pets are ready for their new owners.


As he prepares to transition out of his role, he is set to hand over the responsibilities to Billy Crow, who is scheduled to assume his position on the County Council in January.



2. Winter Storm Watch


Snow, sleet or ice possible! Be prepared.





Staying **warm** when the power is out



If you must venture outdoors during extreme
