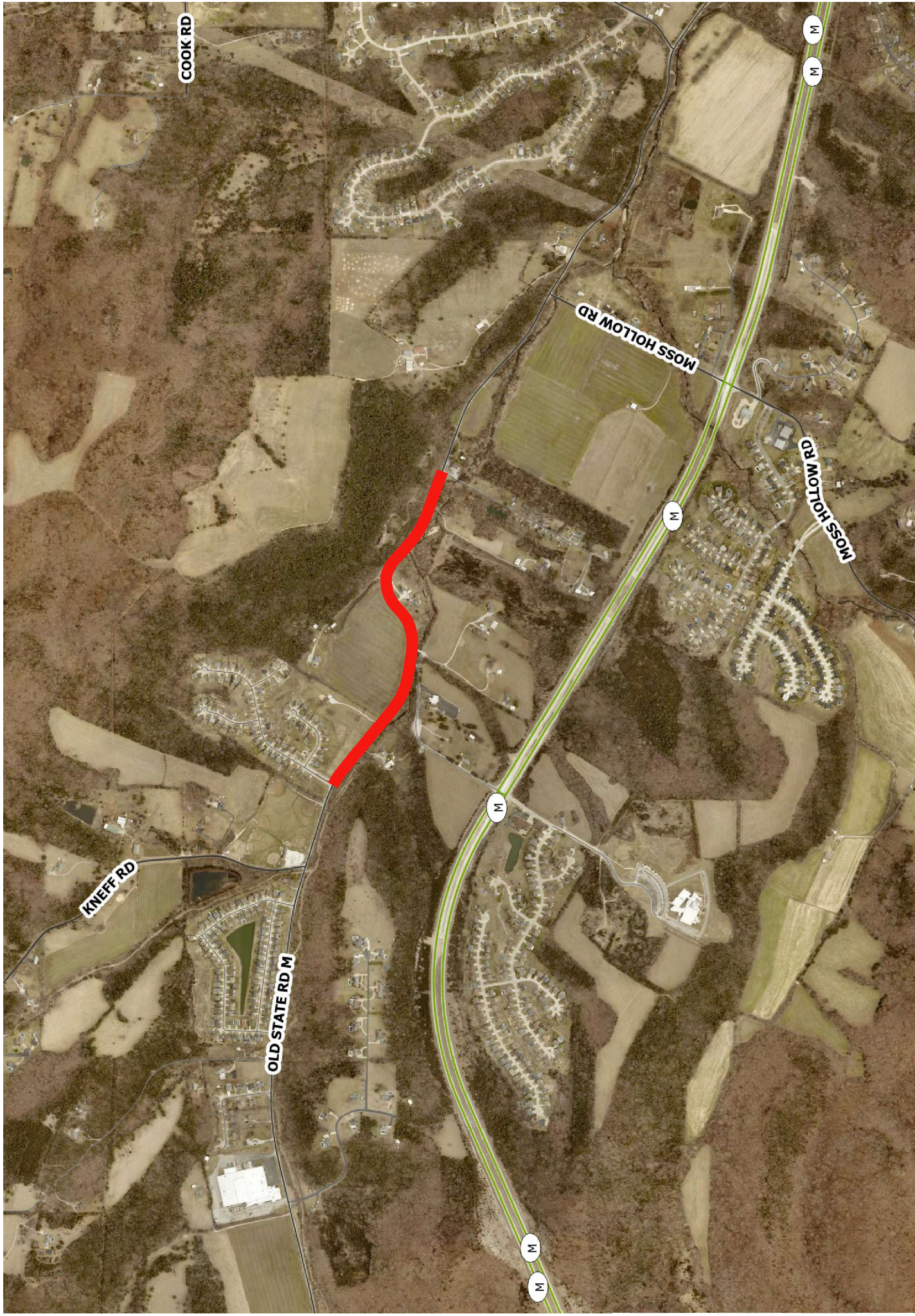

A public meeting will be held on Tuesday, June 3rd, 2025, from 4:00 PM to 7:00 PM at the Jefferson County Windsor Branch Library at 7479 Metropolitan Boulevard, Barnhart, MO 63012. Jefferson County, Missouri is proposing improvements to Old Highway M from Chasteen Lane to Glenstone Drive. Improvements include adding 4' Type A3 shoulders, center and edge line rumble strips, guardrail, and enhanced warning signs. Ditching, upgrading driveway pipes, extending a box culvert, and the addition of high friction surface treatment will also be included. The roadway alignment will change to soften and flatten horizontal curves.
