**AN ORDINANCE TO RENEW COVERAGE FOR COMMERCIAL PROPERTY COVERAGE, BOILER AND MACHINERY, AND FIDELITY AND CRIME AND AUTOMOBILE LIABILITY, AUTOMOBILE PHYSICAL DAMAGE, PUBLIC OFFICIALS ERRORS AND OMISSIONS, EMPLOYMENT PRACTICE LIABILITY, LAW ENFORCEMENT LIABILITY, AND GENERAL LIABILITY INSURANCE WITH MISSOURI PUBLIC ENTITY RISK MANAGEMENT FUND (MOPERM).**

**WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") recommends the renewal coverage of Commercial Property Coverage, Boiler and Machinery, and Fidelity and Crime insurance coverage and coverage of Law Enforcement Liability, Automobile Liability, General Liability, Employment Practice Liability, Public Officials Errors and Omissions, Automobile Physical Damage, insurance coverage with Missouri Public Entity Risk Management Fund (MOPERM); and

**NOW, THEREFORE, BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL, AS FOLLOWS:**

Section 1. The County authorizes the renewal for 2010 the following lines of insurance at the below stated deductibles and estimated annual premiums with MOPERM as follows:

A:	Commercial Property Coverage, Boiler and Machinery and Fidelity and Crime insurance coverage for an estimated annual premium of	\$150,010.00
B:	Law Enforcement Liability	\$150,729.00
C:	Automobile Liability	\$ 78,466.00
D:	General Liability	\$ 51,445.00

The County Executive is further authorized to take any and all actions necessary to carry out the intent of this Ordinance.


