FOR NO INSURANCE, IF YOU PROVIDED PROOF OF INSURANCE AT THE TIME OF THE VIOLATION, IT WILL BE DISMISSED.
IF YOU PROVIDE CURRENT PROOF OF INSURANCE, IT WILL BE AMENDED TO A NON-POINT VIOLATION WITH A FINE.

ANY OFFENSE NOT SPECIFICALLY LISTED AS PAYABLE THROUGH THE VIOLATIONS BUREAU IS A MUST-APPEAR VIOLATION.
