**SUMMARY**

In an effort to update the Jefferson County Code of Ordinances, Title III, Chapter 305 – Traffic Code, the Jefferson County Public Works Department has several recommendations for changes that should be made. The following is a summary of the proposed amendments to the Traffic Code:
