INTRODUCED BY COUNCIL MEMBER(s) Tullock

**AN ORDINANCE AMENDING THE JEFFERSON COUNTY, MISSOURI, CODE OF ORDINANCES, TITLE III, SCHEDULES III AND VI OF THE TRAFFIC CODE, AND PROVIDING FOR AN EFFECTIVE DATE THEREOF, AFFECTING COUNCIL DISTRICTS 1, 3, 5, AND 7.**

**WHEREAS**, the Jefferson County, Missouri, Council, (hereafter "Council") previously enacted the Jefferson County, Missouri, Code of Ordinances, Title III-Traffic Code, (hereafter "Traffic Code") for the purpose of controlling vehicular traffic upon the public roads and highways in the unincorporated area of Jefferson County, Missouri; and,

**WHEREAS**, the Council has amended, from time to time, the Traffic Code when deemed necessary and appropriate; and,

**WHEREAS**, the Council desires to further amend the Traffic Code; and,

**WHEREAS**, the Public Works Department recommends adding one Stop Sign on Biltmore Drive at Northwest Boulevard; and,

**WHEREAS**, the Public Works Department recommends adding one crosswalk on High Ridge Boulevard, approximately 50 feet north of Alpine Court; and,

**WHEREAS**, the Public Works Department has assumed maintenance of Greystone Estates and Quail Run Plat 2 and 3 subdivisions, and now recommends the

aforementioned roadways be added to Schedule III for the purpose of traffic control enforcement; and,

**WHEREAS**, the Council conducted public hearings as required by Section 304.130 RSMo. for the purpose of receiving public comments regarding proposed amendments to the Traffic Code; and,

**WHEREAS**, the Council finds that it is in the best interest of Jefferson County, Missouri, to adopt the proposed amendments to the Jefferson County, Missouri, Code of Ordinances, Title III, Schedules III and VI.

**BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI,  
COUNCIL, AS FOLLOWS:**

Section 1: The Jefferson County, Missouri, Code of Ordinances, Title III, Schedules III and VI are hereby amended as follows:

**1. Schedule III: Speed Limits and Stop Sign Placements**

**ADD to SCHEDULE III, TABLE III-A**

**2. Schedule VI: School and Other Pedestrian Crosswalks and Stop Signs

**PEDESTRIAN CROSSWALKS USING PEDESTRIAN**

**CROSSWALK SIGNS (W11-2 AND W16-7P)**

**Location**

One on High Ridge Boulevard, approximately 50 feet, north of Alpine Court.

Section 2. Copies of the amended Jefferson County, Missouri, Code of Ordinances, Title III, Schedules III and IV shall be kept on file in the office of the County Clerk and the same shall be codified into the Jefferson County Code of Ordinances.

Section 3. A copy of this Ordinance shall be published in a newspaper of general circulation in Jefferson County, Missouri, and posted in a public place in each Council District and on the Jefferson County web page, as required by Article III, Section 3.5.4 of the Home Rule Charter of Jefferson County, Missouri.

Section 4. This Ordinance shall be in full force and effect thirty (30) days after it has been posted and published as required by Section Three (3) above. If any part of this

Ordinance is invalid for any reason, such invalidity shall not affect the remainder of this Ordinance.


