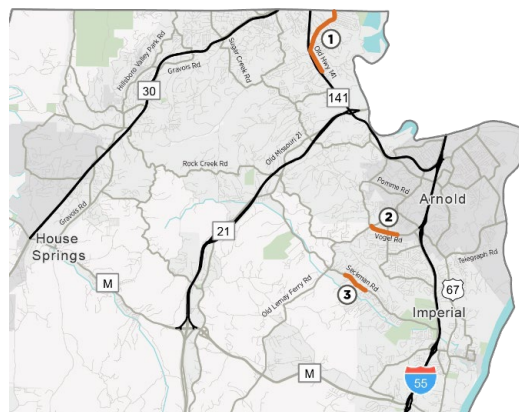

20. Project Details:

Seckman Road (Frisco Rd. to Seckman Senior High School) - 0.7 miles: This segment of Seckman Road will be transformed within its existing shoulder space to create a safe, dedicated space for students and residents to walk and bike to school. The project will add a dual path for walking and biking using bollards and paint, addressing the safety concerns of those vulnerable road using space in an unprotected should.

Old Hwy 141 (Fiedler Lane to St. Louis County) - 2 miles: The project will install bollards and paint to create separation between pedestrians and vehicular traffic, enhancing safety for all users.

Vogel Road (Arnold City Limits to Old Lemay Ferry Road) - 0.72 miles: Vogel Road currently features a five-lane section without provisions for walking or biking. The project will add dedicated dual-use walking and biking paths on each shoulder using bollards and paint.
