Re: Request for bid for **general veterinarian services**

The County of Jefferson is seeking a licensed, practicing veterinarian to provide veterinary services for the Jefferson County Animal Control Center, located at 7105 Shelter Road, Barnhart. These services will vary, based on need, from performing animal sterilization and health checks to euthanasia.

Animals adopted from the Division of Animal Control will have an appointment scheduled with the veterinarian for its health check, vaccinations and sterilization. The animal will be delivered to the veterinarian's office on the morning of the sterilization appointment and the new adopters will pick the animal up from the veterinarian following its procedures. The Division of Animal Control must also euthanize animals that are too sick or injured to economically treat; and animals that are too aggressive and would pose a threat to public safety if they were released into the public. As the Animal Control Center is a government agency that cannot turn away animals when the facility is full, sometimes adoptable animals must be euthanized due to shelter population control.
