3 BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI,
4 COUNCIL, AS FOLLOWS:

5 Section 1. The County awards the following bid which is incorporated by this
6 reference as if fully set out herein, to the lowest responsive bidder for the project as
7 follows:

15 Huxco Construction & Remodeling, Inc.

16 Section 2. The Jefferson County, Missouri, Council hereby authorizes the County
17 Executive to execute any agreements or contracts necessary to effectuate the award of the
18 bid set forth in this Ordinance. A copy of said agreement is attached hereto as Exhibit A.
19 The County Executive is further authorized to take any and all actions necessary to carry
20 out the intent of this Ordinance.

21 Section 3. Copies of the Invitation for Bid, responses thereto, and any contract
22 agreements shall be maintained by the Department of the County Clerk consistent with

1 the rules and procedures for the maintenance and retention of records as promulgated by
2 the Secretary of State.

3 Section 4. This Ordinance shall be in full force and effect from and after its date
4 of approval. If any part of this Ordinance is invalid for any reason, such invalidity shall
5 not affect the remainder of this Ordinance.


