9        **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") in response to  
10       a certain Invitation for Bid issued by the County, received bids for the following project:

18        **WHEREAS**, after reviewing the bids set forth above, the County has determined  
19       that a certain bid represents the lowest and best bid for the respective project and meets  
20       the bid proposal specifications issued by the County; and

1       **WHEREAS**, the Jefferson County, Missouri, Department of Public Works finds  
2   it is in the best interest of the County to award the bid to Pace Construction Company,  
3   LLC., upon approval by the County Council and the County Executive for an amount not  
4   to exceed \$536,680.00 subject to budgetary limitations. A copy of said agreement is

6       **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI,**  
7   **COUNCIL, AS FOLLOWS:**

8       Section 1. The County awards the following bid which is incorporated by this  
9   reference as if fully set out herein, to the lowest and best bidder for the project as follows:

18       Section 2. The Jefferson County, Missouri, Council hereby authorizes the County  
19   Executive to execute any agreements or contracts necessary to effectuate the award of the  
20   bid set forth in this Ordinance. A copy of said agreement is attached hereto as Exhibit A.  
21   The County Executive is further authorized to take any and all actions necessary to carry  
22   out the intent of this Ordinance.

1        Section 3. Copies of the Invitation for Bid, responses thereto, and any contract  
2 agreements shall be maintained by the Department of the County Clerk consistent with  
3 the rules and procedures for the maintenance and retention of records as promulgated by  
4 the Secretary of State.

5        Section 4. This Ordinance shall be in full force and effect from and after its date  
6 of approval. If any part of this Ordinance is invalid for any reason, such invalidity shall  
7 not affect the remainder of this Ordinance.






