Proposition KIDS

Shall the School District of the City of De Soto, Jefferson County, Missouri Board of Education borrow money in the amount of Nine Million Five Hundred Thousand Dollars (\$9,500,000), resulting in no estimated increase to the debt service property tax levy, for the purpose of providing funds for the site development, construction, equipping and furnishing of a new cafeteria at the secondary campus by connecting the high school and junior high school buildings and a new gymnasium, classrooms, and library at Vineland Elementary; to convert the existing library at Vineland Elementary into classrooms; to complete other renovations, repairs and security system improvements to the existing facilities of the District including heating, ventilation and air conditioning upgrades at Athena Elementary; and issue bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.8707 per one hundred dollars of assessed valuation of real and personal property.
