Proposition 1 (4/7ths Majority)

Shall the Board of Education of the School District of the City of De Soto, Jefferson County, Missouri, borrow money in the amount of Seven Million Six Hundred Thousand Dollars (\$7,600,000) for the purpose of providing funds for the construction, equipping, and furnishing of school facilities to replace those damaged by the tornado in May 2003; to complete other improvements and additions to the existing facilities of the District; to fund a portion of the interest due on the bonds during construction; and issue bonds for the payment thereof?

Proposition 1 (Simple Majority)

Shall the Board of Education of the School District of Sunrise R-IX of De Soto, Jefferson County, Missouri, be authorized to eliminate fully the reduction in the operating tax levy for school purposes as provided in Section 164.013 R.S.Mo, as amended (Proposition C Rollback), to provide funds to meet additional operating expenses of the District?

Meramec Valley R-3 School District of Franklin, St. Louis and Jefferson Counties

Proposition 3 (Simple Majority)

Shall the Board of Education of Meramec Valley R-III School District of Franklin, St. Louis and Jefferson Counties, Pacific, Missouri, be authorized to increase the operating tax levy ceiling of the District to \$3.34 per one hundred dollars of assessed valuation, for the purpose of paying operating costs of the District?

If this proposition is approved, the adjusted operating levy of the District is estimated to increase by forty-five cents (\$0.45) per one hundred dollars of assessed valuation, from the current operating levy of \$2.89 to \$3.34 per one hundred dollars of assessed valuation.

Shall the Board of Directors of the Jefferson R-7 Fire Protection District of Jefferson County, Missouri, be authorized to levy an additional tax of Five Cents (5-cents) per One Hundred dollars (\$100) of assessed valuation in each of the years 2003 through 2007, inclusive, to provide funds for the hiring of additional personnel, building maintenance, and firefighting equipment?

Valle Ambulance District

Proposition Valle Ambulance (Simple Majority)

Shall the Board of Directors of the Valle Ambulance District of Jefferson County, Missouri, be authorized to increase the levy for the General Operating Fund by twenty-five cents (25¢) on the one hundred dollar assessed valuation in the following manner: Ten cents (10¢) in 2003, Five cents (5¢) in 2004, Five cents (5¢) in 2005, and Five cents (5¢) in 2006, for a total levy of .4595 cents on the one hundred dollar assessed valuation for the necessary support of the district and for the public health of its inhabitants?
