STATE OF MISSOURI - CONSTITUTIONAL AMENDMENT NO. 2

Proposed by the 88th General Assembly (First Regular Session)

School districts with voter approval, may incur bonded indebtedness up to fifteen percent of the value of property located in district rather than current level of ten percent. Fiscal impacts due to this proposal would depend upon actions of school boards and voters in school districts.

COUNTY OF JEFFERSON - PROPOSITION P (Needed Simple Majority)

Shall the County of Jefferson impose a local use tax at the same rate as the total local sales tax rate, currently one and one-half percent (1.50%), provided that if the local sales tax rate is reduced or raised by voter approval, the local use tax rate shall also be reduced or raised by the same action? A use tax return shall not be required to be filed by persons whose purchases from out of state vendors do not in total exceed two thousand dollars in any calendar year.

COUNTY OF JEFFERSON - PROPOSITION H (Needed Simple Majority)

Shall Jefferson County establish, improve, and maintain sheltered workshops, residence facilities and related services for developmentally disabled and handicapped persons, and for which the county shall levy an additional tax of five cents (\$.05) for each one hundred dollars (\$100) assessed valuation thereof? If approved, the total levy will be fifteen cents (\$.15) for each one hundred dollars (\$100) assessed valuation.

HILLSBORO R-3 SCHOOL DISTRICT - PROPOSITION (Needed Simple Majority)

Shall the Board of Education of the Hillsboro R-III School District of Jefferson County, Missouri be authorized each year to eliminate the reduction in its operating levy required under section 164.013, RSMo?

(Approval of this proposition would permit the District to receive the full benefit of the state one-cent sales tax for education without reducing its operating levy.)

DUNKLIN R-V SCHOOL DISTRICT - PROPOSITION 1 (Needed 4/7 Majority)

Shall the Board of Education of the Dunklin R-V School District, Missouri, borrow money in an amount not to exceed One Million Five Hundred Thousand Dollars (\$1,500,000) for the acquisition, equipping, and betterment of school facilities, including, without limitation, the acquisition, construction, equipping, and furnishing of additional classrooms, and various remodeling and equipping improvements (primarily energy conservation related, such as window replacement, air conditioning, roof repairs, etc.) to the high school, Pevely and Herculaneum Elementary Schools, the acquisition and installation of computer technology equipment, and other improvements to existing School District facilities, and issue bonds for the payment thereof?

NO. ST. FRANCOIS CO. R-1 SCHOOL DISTRICT - PROPOSITION 1 (Needed 4/7 Majority)

Shall the Board of Education of the North St. Francois County R-1 School District, Missouri, borrow money in an amount not to exceed Six Million Five Hundred Thousand Dollars (\$6,500,000) for the purpose of the acquisition, constructing, equipping, furnishing and betterment of school facilities including, without limitation, the constructing, equipping, and furnishing of a fifth and sixth grade attendance center at Cantwell Elementary School and constructing, equipping, and furnishing additional classrooms at the High School and Central Elementary School as needed; acquisition and installation of computer technology equipment and other improvements, and issue bonds for the payment thereof?

CITY OF CRYSTAL CITY - PROPOSITION (Needed Simple Majority)

Shall the City of Crystal City impose a sales tax of 1/4 of 1% for a period not to exceed five years on the receipts from the sales at retail of all tangible personal property of taxable services at retail if such property and services are subject to the sales tax imposed by the State of Missouri, said sales tax to be for the purpose of providing funding for storm water control for the City of Crystal City?

CITY OF FESTUS - PROPOSITION (Needed Simple Majority)

Shall the City of Festus impose a sales tax of 1/4 of One percent (1%) on the receipts from sale at retail of all tangible personal property or taxable services at retail within the city limits of the City of Festus, Missouri, if such property and taxable services are subject to taxation by the State of Missouri under the provisions of Chapter 144.010 to 144.525, RSMo. 1995, as amended, for the purpose of providing funding for storm water control and local parks for the City of Festus; and upon the imposition of said sales tax there followed the reduction of the Municipal Tax Levies for general and special revenue purposes from \$0.72 on each \$100 assessed valuation to \$0.45 on each \$100 assessed valuation.

CITY OF PEVELY - PROPOSITION 1 (Needed Simple Majority)

Shall the City of Pevely impose a local use tax at the same rate as the local sales tax, currently at a rate of .015% provided that if any local sales tax is repealed, reduced or raised by voter approval, the respective local use tax shall also be repealed, reduced or raised by the same action? A use tax return shall not be required to be filed by persons whose purchases from out of state vendors do not in total exceed two thousand dollars in any calendar year.
