OFFICIAL BALLOT

PROPOSITION B

Requires greater accountability for education spending including reports to taxpayers on school performance. Establishes a special fund with additional tax revenues earmarked for education reforms, including smaller classes, job training, student aid and college improvements. Additional \$385 million generated would be spent on schools, job training and colleges. Increases corporate, tobacco, and sales taxes. Provides tax relief for families with dependents. Eliminates some deductions for upper income individual taxpayers.

PROPOSITION NO. 1 - GC

(simple majority for passage).

(simple majority required for passage).

QUESTION NO. 2

Shall the board of education of Northwest R-1 School district of Jefferson County, Missouri, be authorized to increase the tax levy for the purpose of providing and operating a new high school by \$.81 per \$100 of assessed valuation?

If this question is approved by the voters, the new tax rate ceiling for the operating levy, without regard to the increase requested in question No. 3, will be \$4.34 per \$100 of assessed valuation less the annual reduction resulting from sales tax revenues that are allocated to the district. (the tax levy reduction for the current year is \$.80).

Shall the board of education of Northwest R-1 school district of Jefferson County, Missouri, be authorized to increase the tax levy for the purpose of increasing salaries and other benefits of personnel by \$.83 per \$100 of assessed valuation?

If this question is approved by the voter, the new tax rate ceiling for the operating levy, without regard to the increase requested in question No. 2, will be \$4.36 per \$100 of assessed valuation less the annual reduction resulting from sales tax revenues that are allocated to the district. (the tax levy reduction for the current year is \$.80.)
