1 **AN ORDINANCE AUTHORIZING JEFFERSON COUNTY, MISSOURI**
2 **EXECUTIVE TO EXECUTE AGREEMENTS FOR PROFESSIONAL SERVICES**
3 **FOR ON-CALL STRUCTURAL ENGINEERING SERVICES FOR 2018 AND 2019.**

4 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") has various
5 Public Works Projects for the years of 2018 and 2019 and wishes to enter into agreements
6 attached hereto as Exhibits A1, A2 and A3 with the following firms for professional

2 **WHEREAS**, Jefferson County, Missouri desires that professional services be
3 available for the needs of various Public Works projects; and

4 **WHEREAS**, the Jefferson County, Missouri, finds that it is now necessary and in
5 the best interests of the County to execute agreements for professional services with the
6 above-mentioned firms for the listed amounts, based on their Standard Rate Schedules, for
7 On-Call Engineering Services for various Public Works Projects for 2018 and 2019.

8 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,**

9 AS FOLLOWS:

10 Section 1. The County shall execute agreements with the following firms for
11 professional services for various Public Works Projects.

19 Section 2. The Jefferson County, Missouri, Council hereby authorizes the
20 County Executive to execute the agreements incorporated by reference as Exhibit "A1
21 through A3" and any agreements or contracts necessary to effectuate the award of the bids
22 and proposals set forth in this Ordinance. The County Executive is further authorized to

1 take any and all actions necessary to carry out the intent of this Ordinance. An unexecuted
2 copy of the Agreements is attached hereto as Exhibit "A1 through A3" and incorporated
3 herein, by reference.

4 **Section 3.** Copies of all Invitations for Bid, Requests for Proposals, responses
5 thereto, and any contracts or agreements shall be maintained by the Department of the
6 County Clerk consistent with the rules and procedures for the maintenance and retention
7 of records as promulgated by the Secretary of State.

8 **Section 4.** This Ordinance shall be in full force and effect from and after its
9 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity
10 shall not affect the remainder of this Ordinance.
