3 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,**  
4 **AS FOLLOWS:**

5 Section 1. The County shall execute an agreement with the following firm for  
6 professional services for various Public Works Projects.

12 Section 2. The Jefferson County, Missouri, Council hereby authorizes the  
13 County Executive to execute the agreement incorporated by reference as Exhibit "A1" and  
14 any agreement or contract necessary to effectuate the award of the bids and proposals set  
15 forth in this Ordinance. The County Executive is further authorized to take any and all  
16 actions necessary to carry out the intent of this Ordinance. An unexecuted copy of the  
17 Agreement is attached hereto as Exhibit "A1" and incorporated herein, by reference.

18 Section 3. Copies of all Invitations for Bid, Requests for Proposals, responses  
19 thereto, and any contracts or agreements shall be maintained by the Department of the  
20 County Clerk consistent with the rules and procedures for the maintenance and retention  
21 of records as promulgated by the Secretary of State.

1           Section 4.     This Ordinance shall be in full force and effect from and after its  
2     date of approval. If any part of this Ordinance is invalid for any reason, such invalidity  
3     shall not affect the remainder of this Ordinance.




