1 **AN ORDINANCE TO AUTHORIZE THE COUNTY EXECUTIVE TO**
2 **AWARD THE ENGINEERING SERVICES CONTRACT AND TO EXECUTE**
3 **THE AGREEMENT BETWEEN THE COUNTY OF JEFFERSON AND ABNA**
4 **ENGINEERING, INC. FOR THE CHARTER CHURCH ROAD BRIDGE AT**
5 **MITCH SWEET ROAD BRIDGE REPLACEMENT DESIGNATED AS**
6 **PROJECT STP-5403 (673) IN COUNCIL DISTRICTS 5 & 6.**

7 **WHEREAS**, The County of Jefferson Missouri issued a Request for
8 Qualifications for design, right of way and construction services for the Charter Church
9 Road Bridge at Mitch Sweet Road Bridge Replacement designated as project STP-5403
10 (673); and

11 **WHEREAS**, The County of Jefferson Missouri in response to a certain Request
12 for Qualifications issued by the County, received proposals for design, right of way and
13 construction services for the Charter Church Road Bridge at Mitch Sweet Road Bridge
14 Replacement designated as project STP-5403 (673); and

15 **WHEREAS**, after reviewing the proposals, the County selected four qualified
16 engineering firms to interview for the Charter Church Road Bridge at Mitch Sweet Road
17 Bridge Replacement Project. Those firms were ABNA Engineering, Inc., EFK Moen,
18 LLC, Structures, Inc. and CDG Engineers; and

1 **WHEREAS**, after interviewing the four qualified engineering firms, the County
2 has determined that a certain engineering firm, ABNA Engineering, Inc. represents the
3 best qualified proposal for the project and meets the Request for Qualifications by the
4 County; and

5 **WHEREAS**, the County of Jefferson finds it now necessary and in the best
6 interest of the County to award the Charter Church Road Bridge at Mitch Sweet Road
7 Bridge Replacement Project to ABNA Engineering, Inc. as the best qualified firm and to
8 execute an agreement for the design, right of way and construction services contract not
9 to exceed one hundred seventy-six thousand twelve dollars and ten cents (**\$176,012.10**),
10 conditional on the concurrence of the Missouri Department of Transportation and the
11 Federal Highway Administration. A copy of said agreement is attached hereto as Exhibit
12 A.

13 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI,**
14 **COUNCIL, AS FOLLOWS:**

15 Section 1. The County awards the design, right of way and construction services
16 contract for the Charter Church Road Bridge at Mitch Sweet Road Bridge Replacement
17 Project to the best qualified firm for the project, being ABNA Engineering, Inc. in the
18 amount of one hundred seventy-six thousand twelve dollars and ten cents (**\$176,012.10**).

19 Section 2. The County Council authorizes the County Executive to execute any
20 agreement or document necessary to effectuate the award of the contract set forth in the
21 Ordinance. A copy of said agreement is attached hereto as Exhibit A and incorporated by
22 reference.

1 Section 3. Copies of all Request for Qualifications, responses thereto, any contract
2 agreements and change orders shall be maintained by the Department of the County
3 Clerk consistent with the rules and procedures for the maintenance and retention of
4 records as promulgated by the Secretary of State.

5 Section 4. This Ordinance shall be in full force and effect from and after its date
6 of approval. If any part of this Ordinance is invalid for any reason, such invalidity shall
7 not affect the remainder of this Ordinance.






