5 **COUNTY EXECUTIVE TO EXECUTE ANY NECESSARY AGREEMENTS OR**
6 **CONTRACTS TO EFFECTUATE THE AWARD OF THE BID FOR A PROJECT**

8 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") in response to

1 **WHEREAS**, the Jefferson County, Missouri, Department of Public Works finds
2 it is in the best interest of the County to award the bid to Gerstner Electric, Inc. upon
3 approval by the County Council and the County Executive for an amount not to exceed
4 \$99,091.00 subject to budgetary appropriations. A copy of said agreement is attached

6 BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI,
7 COUNCIL, AS FOLLOWS:

8 Section 1. The County awards the following bid which is incorporated by this
9 reference as if fully set out herein, to the lowest responsive bidder for the project as
10 follows:

18 Gerstner Electric, Inc.

19 Section 2. The Jefferson County, Missouri, Council hereby authorizes the County
20 Executive to execute any agreements or contracts necessary to effectuate the award of the
21 bid set forth in this Ordinance. A copy of said agreement is attached hereto as Exhibit A.

1 The County Executive is further authorized to take any and all actions necessary to carry
2 out the intent of this Ordinance.

3 Section 3. Copies of the Invitation for Bid, responses thereto, and any contract
4 agreements shall be maintained by the Department of the County Clerk consistent with
5 the rules and procedures for the maintenance and retention of records as promulgated by
6 the Secretary of State.


7 Section 4. This Ordinance shall be in full force and effect from and after its date

9 not affect the remainder of this Ordinance.


