4 **AND AUTHORIZATION FOR THE COUNTY EXECUTIVE TO EXECUTE ANY**
5 **NECESSARY AGREEMENTS OR CONTRACTS TO EFFECTUATE THE**
6 **AWARD OF THE BID FOR A PROJECT IN COUNCIL DISTRICTS 6 AND 7.**

7 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") in response to
8 a certain Invitation for Bid issued by the County, received bids for the following project:

15 **WHEREAS**, after reviewing the bids set forth above, the County has determined
16 that a certain bid represents the lowest responsive bid for the respective project and meets
17 the bid proposal specifications issued by the County, conditional on the concurrence of
18 the Missouri Department of Transportation and the Federal Highway Administration; and

1 **WHEREAS**, the Jefferson County, Missouri, Council finds it is in the best
2 interest of the County to award the bid to KCI Construction Company, Inc. upon approval
3 by the County Council, the County Executive, the Missouri Department of Transportation
4 and the Federal Highway Administration for an amount not to exceed \$562,140.55
5 subject to budgetary limitations. A copy of said agreement is attached hereto as Exhibit
6 A.

7 BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI,
8 COUNCIL, AS FOLLOWS:

9 Section 1. The County awards the following bid which is incorporated by this
10 reference as if fully set out herein, to the lowest responsive bidder for the project as
11 follows:

20 Section 2. The Jefferson County, Missouri, Council has

21 Executive to execute any agreements or contracts necessary to effectuate the award of the
22 bid set forth in this Ordinance. A copy of said agreement is attached hereto as Exhibit A.

1 The County Executive is further authorized to take any and all actions necessary to carry
2 out the intent of this Ordinance.

3 Section 3. Copies of the Invitation for Bid, responses thereto, and any contract
4 agreements shall be maintained by the Department of the County Clerk consistent with
5 the rules and procedures for the maintenance and retention of records as promulgated by
6 the Secretary of State.

7 Section 4. This Ordinance shall be in full force and effect from and after its date
8 of approval. If any part of this Ordinance is invalid for any reason, such invalidity shall
9 not affect the remainder of this Ordinance.




