

1 **WHEREAS**, the Jefferson County, Missouri, Council finds it is in the best
2 interest of the County to award the bid to Kozeny-Wagner, Inc. upon approval by the
3 County Council, the County Executive, the Missouri Department of Transportation and
4 the Federal Highway Administration for an amount not to exceed \$536,692.60 subject to
5 budgetary limitations. A copy of said agreement is attached hereto as Exhibit A.

6 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI,**
7 **COUNCIL, AS FOLLOWS:**

8 Section 1. The County awards the following bid which is incorporated by this
9 reference as if fully set out herein, to the lowest responsive bidder for the project as
10 follows:

11 BID NAME

12 Maness Road Bridge

13 TERM

14 Upon approval by the County Council and County Executive until completed

15 AMOUNT

16 Up to \$536,692.60 subject to budgetary limitations

17 AWARDED BIDDER

18 Kozeny-Wagner, Inc.

19 Section 2. The Jefferson County, Missouri, Council hereby authorizes the County
20 Executive to execute any agreements or contracts necessary to effectuate the award of the
21 bid set forth in this Ordinance. A copy of said agreement is attached hereto as Exhibit A.

1 The County Executive is further authorized to take any and all actions necessary to carry
2 out the intent of this Ordinance.

3 Section 3. Copies of the Invitation for Bid, responses thereto, and any contract
4 agreements shall be maintained by the Department of the County Clerk consistent with
5 the rules and procedures for the maintenance and retention of records as promulgated by
6 the Secretary of State.


7 Section 4. This Ordinance shall be in full force and effect from and after its date
8 of approval. If any part of this Ordinance is invalid for any reason, such invalidity shall
9 not affect the remainder of this Ordinance.




