9 Section 1. The County shall execute agreements with the following firms for

18 Section 2. The Jefferson County, Missouri, Council hereby authorizes the
19 County Executive to execute the agreement incorporated by Reference as Exhibit "A1
20 through A3" and any agreements or contracts necessary to effectuate the award of the
21 bids and proposals set forth in this Ordinance. The County Executive is further
22 authorized to take any and all actions necessary to carry out the intent of this Ordinance.

1 An unexecuted copy of the Agreement is attached hereto as Exhibit "A1 through A3" and
2 incorporated herein, by reference.

3 Section 3. Copies of all Invitations for Bid, Requests for Proposals, responses
4 thereto, and any contracts or agreements shall be maintained by the Department of the
5 County Clerk consistent with the rules and procedures for the maintenance and retention
6 of records as promulgated by the Secretary of State.


7 Section 4. This Ordinance shall be in full force and effect from and after its
