2 the best interests of the County to execute agreements for professional services with the

5       **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI,**

7       Section 1.     The County shall execute agreements with the following firms for

15       Section 2.     The Jefferson County, Missouri, Council hereby authorizes the  
16 County Executive to execute the agreement incorporated by Reference as Exhibit "A1  
17 and A2" and any agreements or contracts necessary to effectuate the award of the bids  
18 and proposals set forth in this Ordinance. The County Executive is further authorized to  
19 take any and all actions necessary to carry out the intent of this Ordinance. An  
20 unexecuted copy of the Agreement is attached hereto as Exhibit "A1 through A3" and  
21 incorporated herein, by reference.

1        Section 3.       Copies of all Invitations for Bid, Requests for Proposals, responses  
2       thereto, and any contracts or agreements shall be maintained by the Department of the  
3       County Clerk consistent with the rules and procedures for the maintenance and retention  
4       of records as promulgated by the Secretary of State.

5       Section 4.       This Ordinance shall be in full force and effect from and after its  
6       date of approval. If any part of this Ordinance is invalid for any reason, such invalidity  
7       shall not affect the remainder of this Ordinance.




