NRC WAIVERS:

- Customers will receive a waiver of normally applicable Service Ordering and Line Connection nonrecurring charges (NRC's) associated with the establishment of all local exchange access lines (new, winback, additional line, and move) that are subscribed to AT&T Business Local Calling, as well as a waiver of NRC's, if applicable, associated with vertical features ordered at the time of initial subscription to AT&T Business Local Calling. This waiver of NRCs is not applicable for customers subscribing to a Month-to-Month plan.
- Service charges associated with changing to/from hunting service and changing to/from system bill on arrangement, if applicable, are also waived.
- For account conversions, Listing NRCs are waived when converting a listing from the 1FLs to the B1W.
- Standard NRC's will apply to stand alone features added to an existing AT&T Business Local Calling account when such features are added subsequent to the initial subscription.

Other Pricing Information:

- Business Local Calling will be priced with single price point per line for monthly recurring charges. There will be no price variation across rate groups or access areas. The price point per line will include all core and optional components of the package.
- Customers can add additional products; however they will be billed as a separate item from Business Local Calling.

Pricing is available with Month to Month, 12, 24, and 36 month term plans.
