1 **AN ORDINANCE REJECTING ALL BIDS FOR THE RESPONSES TO**

4 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") in response to
5 certain Invitations for Bid and Requests for Proposals issued by the County received bids

18 construction schedule is inadequate; and

6 approval by the County Council and County Executive.

7 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI,**

9 Section 1. The County rejects the following bids and proposals which are
10 incorporated by this reference as if fully set out herein:

14 Upon approval by the County Council and County Executive

15 Section 2. The County rejects the bid as recommended by the Public Works
16 Department due to none of the bids submitted were appropriate to cover all of their
17 product needs for the Equipment Rental Services.

18 Section 3. This Ordinance shall be in full force and effect from and after its
19 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity
20 shall not affect the remainder of this Ordinance.


