6 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") for the
7 Juvenile Office requires certain security services; and,

1 **WHEREAS**, Jefferson County, Missouri, received two (2) bids for Security

9 State of Missouri, Hillsboro, Missouri, for the Jefferson County Juvenile Office and that
10 said rejection shall be formally approval by the County Council and County Executive.


