1 **AN ORDINANCE REJECTING ALL BIDS FOR THE RESPONSES TO**
2 **CERTAIN INVITATIONS FOR BID AND REQUESTS FOR PROPOSALS FOR**
3 **LAWN CARE AND SNOW REMOVAL SERVICES FOR THE JEFFERSON**
4 **COUNTY, MISSOURI DEPARTMENT OF COUNTY SERVICES AND CODE**
5 **ENFORCEMENT, DIVISION OF ANMIMAL CONTROL.**

6 **WHEREAS**, Jefferson County, Missouri, (hereafter, the “County”) for the
7 Department of County Services and Code Enforcement, Division of Animal Control

WHEREAS, Jefferson County, Missouri, received one (1) bids for the Lawn Care and Snow Removal Services for the Department of County Services and Code Enforcement, Division of Animal Control that were opened on May 20, 2014; and,

WHEREAS, the Jefferson County Department of County Services and Code Enforcement, Division of Animal Control recommends that the bids be rejected due to the cost of the lawn care and snow removal services needed for the Department of County Services and Code Enforcement, Division of Animal Control; and

WHEREAS, the Jefferson County, Missouri, Council finds that it is in the best interest of the County to reject the bids for the Lawn Care and Snow Removal Services for the Department of County Services and Code Enforcement, Division of Animal Control and that said rejection shall be formally approval by the County Council and County Executive.






