1 **AN ORDINANCE REJECTING ALL BIDS FOR THE RESPONSES TO**
2 **CERTAIN INVITATIONS FOR BID AND REQUESTS FOR PROPOSALS FOR**
3 **LAWN CARE AND SNOW REMOVAL SERVICES FOR THE JEFFERSON**
4 **COUNTY, MISSOURI DEPARTMENT OF COUNTY SERVICES AND CODE**
5 **ENFORCEMENT, DIVISION OF ANIMAL CONTROL.**

6 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") for the
7 Department of County Services and Code Enforcement, Division of Animal Control

8 **WHEREAS**, the Jefferson County, Missouri, Council finds that it is in the best
9 interest of the County to reject the bids for the Lawn Care and Snow Removal Services
10 for the Department of County Services and Code Enforcement, Division of Animal
11 Control and that said rejection shall be formally approval by the County Council and
12 County Executive.




