Addendum 1

BID OPENING DATE HAS BEEN CHANGED TO OPEN THE PROPOSALS ON:

TUESDAY, JUNE 10, 2014 AT 2:00 PM

Please send the necessary addendums to all vendors requesting bid specifications for the playground project.

- Question One: Is the playground surfacing tile or shredded rubber?
- Answer One: The playground surface shall be shredder material meeting current ADA requirements. The material may be shredded rubber or shredded natural material but is must meet current ADA requirements.
- Question Two: There are specification requirements referring to HIC tests 9-12 months after install date. Is this required for the shredded play surface?
- Answer Two: No. The post installation HIC test requirements were part of the required specifications with a tile play surface. The specifications were changed to include shredded play surface. Disregard any requirements that are applicable to the tile specifications and not applicable to a shredded play surface requirement.
- Question Three: The supervision only option does not specify what type of supervision is required. What should we bid for this option?
- Answer Three: Bids should cover the cost of a qualified installer supplied by the vendor to be on-site during construction of the playground by park department maintenance employees. The on-site supervision shall be ready to provide instruction on installation procedure to assure proper installation of the playground.
- Question Four: What drainage if any is required under the shredded playground surface?
- Answer Four: The installation of the play surface shall be in compliance with the manufactures requirements. With that said the bidders shall assure that surface will be installed in a manner that will provide for run-off of a typical rain event within three (3) hours of the rain event.
- Question Five: Is a Performance and Bid Bond required?
- Answer Five: Yes, Performance Bond and Bid Bond are required.
- Question Six: Is it the intent to use the entire amount allocated for the project?
- Answer Six: Yes. It is the intent to use the entire amount budgeted for the project (within +/- 1.5% of the budget amount). It is anticipated that the bids come in as close to the budget amount as possible.
 - Question Seven: Is it possible change the pre-bid meeting date to allow more time between the pre-bid meeting and the bid opening?
 - Answer seven: No, it is not possible to alter the pre-bid meeting date. However, the bid opening date can be changed to 2:00pm, June 10, 2014.
