1 **AN ORDINANCE REPEALING ORDINANCE 15-0378 AND AWARDING**
2 **A NEW BIDS FOR CERTAIN PRODUCTS AND SERVICES TO THE LOWEST**
3 **AND BEST BIDDERS AS REFLECTED IN THE RESPONSES TO CERTAIN**
4 **INVITATIONS FOR BID AND REQUESTS FOR PROPOSALS FOR**
5 **DISHWASHER(S); AND AUTHORIZATION FOR THE COUNTY EXECUTIVE**
6 **TO EXECUTE ANY NECESSARY AGREEMENTS OR CONTRACTS TO**
7 **EFFECTUATE THE AWARD OF THE BIDS AND PROPOSALS.**

8 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") approved
9 Ordinance 15-0378 to award bids and proposals for the following items or services:

16 **WHEREAS**, subsequent to the passage of Ordinance 15-0378 and after
17 consultation with Legal Counsel it was determined by the Department of Public Works
18 that Ordinance 15-0378 needed to be repealed due to the immediate necessity for
19 additional dishwasher (4) purchases within the County and the requirements to have

1 maintenance contractual services included for the four (4) dishwashers now vital for
2 operations by the County and its Departments; and,

3 **WHEREAS**, after re-reviewing the bids and proposals set forth above, the
4 Department of Public Works has determined that certain bids and proposals represent the
5 lowest and best bid for the respective items or services and met the bid or proposal
6 specifications issued by the County as set forth herein; and,

7 **WHEREAS**, the Jefferson County, Missouri, Council finds it is in the best
8 interest of the County to repeal Ordinance 15-0378 and award new bids and proposals to
9 Sam Tell and Son Inc. for a term from 09-28-15 to 09-27-16 upon approval by the
10 County Council and County Executive for the total amount up to **\$17,124.00** subject to
11 budgetary limitations for the four (4) dishwashers required by the County.

12 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI,**
13 **COUNCIL, AS FOLLOWS:**

14 Section 1. Ordinance 15-0378 is hereby repealed.

15 Section 2. The County now awards the following bids and proposals which
16 are incorporated by this reference as if fully set out herein, to the lowest and best vendor
17 bidding for each respective item or service as follows:

6 Section 3. The Jefferson County, Missouri, Council hereby authorizes the
7 County Executive to execute the Agreement incorporated by Reference as Exhibit "A"
8 and any agreements or contracts necessary to effectuate the award of the bids and
9 proposals set forth in this Ordinance. The County Executive is further authorized to take
10 any and all actions necessary to carry out the intent of this Ordinance. An unexecuted
11 copy of the Agreement is attached hereto as Exhibit "A" and incorporated herein, by
12 reference.

13 Section 4. Copies of all Invitations for Bid, Requests for Proposals, responses
14 thereto, and any contracts or agreements shall be maintained by the Department of the
15 County Clerk consistent with the rules and procedures for the maintenance and retention
16 of records as promulgated by the Secretary of State.

17 Section 5. This Ordinance shall be in full force and effect from and after its
18 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity
19 shall not affect the remainder of this Ordinance.






