2 which were opened on November 10, 2015; and,

3 **WHEREAS**, the Jefferson County Department of Public Works, Division of Fleet

22 for the Tow Behind Angle Road Sweeper.


1        Section 3.        This Ordinance shall be in full force and effect from and after its
