1 **AN ORDINANCE REJECTING ALL BIDS FOR THE RESPONSES TO**
2 **CERTAIN INVITATIONS FOR BID AND REQUESTS FOR PROPOSALS FOR**
3 **POLICE CANINES 2016 FOR THE JEFFERSON COUNTY, DEPARTMENT OF**
4 **THE SHERIFF.**

1 **WHEREAS**, Jefferson County, Missouri, received two (2) bids for Police Canines
2 2016, for the Jefferson County, Department of the Sheriff and which were opened on
3 December 15, 2015; and,

4 **WHEREAS**, the Jefferson County, Department of the Sheriff recommends that the
5 bids be rejected due to revisions needed for the clarification of the bid specifications for
6 the training for narcotics and patrol canines; and

7 **WHEREAS**, the Jefferson County, Missouri, Council finds that it is in the best
8 interest of the County to reject all the bids for the Police Canines 2016 for Jefferson County,
9 Department of the Sheriff and that said rejection shall be formally approval by the County
10 Council and County Executive.

11 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,**
12 **AS FOLLOWS:**

13 Section 1. The County rejects the following bids and proposals which are

20 Section 2. The County rejects the bid as recommended by the Jefferson
21 County, Department of the Sheriff due to revisions needed in the clarification of the bid

1 Section 3. This Ordinance shall be in full force and effect from and after its
2 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity
3 shall not affect the remainder of this Ordinance.
