1 **AN ORDINANCE REJECTING ALL BIDS FOR THE RESPONSES TO**
2 **CERTAIN INVITATIONS FOR BID AND REQUESTS FOR PROPOSALS FOR**
3 **POLICE CANINES 2016 FOR THE JEFFERSON COUNTY, DEPARTMENT OF**
4 **THE SHERIFF.**

5 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") for the
6 Department of the Sheriff, requires certain training for narcotics and patrol canines; and,

7 **WHEREAS**, the Department of the Sheriff requests that the canines be trained to
8 allow the teams to be certified as a narcotic/patrol dog team with any of nationally
9 recognized police dog organizations; and

9 Department of the Sheriff and that said rejection shall be formally approval by the County

2 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity
3 shall not affect the remainder of this Ordinance.






