





Finance charges in the amount of 1.5% per month may be applied without any prior notice, and at the discretion of Audio Acoustics, Inc. (Audio Acoustics) to all invoices not paid within 60 days. Purchaser agrees to pay all costs of collection including reasonable attorney's fees, court costs and other costs of collections resulting from any default of payment terms of this agreement.

Title to equipment remains with Audio Acoustics until purchase price has been fully paid, at which time title shall transfer to the Purchaser. 

2.0 Scope of Work by Tech Electronics

- 2.1 This proposal provides a Sound Reinforcement System based on a survey of your facility, and/or written, and/or verbal information provided by Randy Muller & Travis Missey.
- 2.2 Tech Electronics, Inc. will provide labor, material, and coordination to install Professional Audio Visual Equipment as described in this submission. This facility exists and this system is quoted as a retrofit/add installation.
- 2.3 This system will be installed with plenum-rated wire where required for low voltage work, and installed in free air space, above ceilings, and in partition walls.
- 2.4 All wiring will be installed within drop ceilings and walls when possible. If building construction does not permit the above, wiring may be enclosed in surface raceway or using standard installation practices.
 - 2.4.1 Any conduit or surface raceway requirements are not included, unless specifically identified in our equipment list.
- 2.5 Tech Electronics representatives will provide one (1) session of up to one (1) hour of system training to instruct your personnel on the operation of your system at the sound system location. Additional or repeat training sessions are available at an additional cost, and will be invoiced on an hourly basis plus travel and expenses.
- 2.6 Provide testing of the added field devices and system operations of the Sound Reinforcement System. If these times are extended because of conditions beyond Tech Electronics control, additional labor will be invoiced at our current labor rates.
- 2.7 Provide and pay for permits and associated fees as required by the Authority Having Jurisdiction and the local Municipality.

SECTION II: SYSTEM PROPOSAL

1.0 System Overview – County Council Microphone System Upgrade

- 1.1 Tech Electronics, Inc. (Tech) proposes to design, furnish, and install a professional sound reinforcement system to fulfill the stated objective in the following details:
 - 1.1.1 Upgrade all of the audio electronics in the existing Communication Room closet. This existing cabinet will contain the following new equipment:
 - 1.1.2 Furnish and install two (2) Telex FMR-500-HD-A wireless microphone systems with receivers mounted in the cabinet and two (2) handheld transmitters to be used in the council chamber room.
 - 1.1.3 Furnish and install one (1) Listen Technologies Confidea CU central processor.
 - 1.1.4 Furnish and install one (1) Lowell MA125 5 input x 125W mixer amplifier.
 - 1.1.5 Furnish and install one (1) Shure DFR22 digital signal processor to perform equalization and digital feedback reduction functions.
 - 1.1.6 Furnish and install one (1) Listen Technologies LS-23-072 hearing assist system with the transmitter mounted in the cabinet & 4 body pack receivers to be used in the council chamber room.
- 1.2 Furnish and install four (4) Lowell ES-62T 6.5" 2-way tuned and ported loudspeaker assemblies mounted in the ceiling of the council chamber room.
- 1.3 Furnish and install one (1) Listen Technologies Confidea FC-M flush mount Chairman wired conferencing microphone with priority cancel switch, push-to-talk switch and integral speakers at the central position permanently mounted into the Chairman's seating position at the dais.
- 1.4 Furnish and install twelve (12) Listen Technologies Confidea FD-M flush mount Delegate wired conferencing microphones with push-to-talk switch and integral speakers permanently mounted at the remaining positions at the dais and at the front locations including the presenter microphone.
- 1.5 Furnish and install new CAT5 cabling for new microphone system.
- 1.6 Program system and provide integration to existing camera switching system so that when presenter microphone is turned on, the camera orientation switches to capture the presenter, and will switch back to the council when the presenter microphone is turned off.
- 1.7 Calibrate & test system and provide training for new system elements.
