4 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") recommends

13 Section 2. The Jefferson County, Missouri, Council hereby authorizes the
14 County Executive to execute a renewal agreement, incorporated herein by reference and
15 attached as Exhibit A. The County Executive is further authorized to take any and all
16 actions necessary to carry out the intent of this Ordinance.

17 Section 3. Copies of all Invitations for Bid, Requests for Proposals, responses
18 thereto, and any contracts or agreements shall be maintained by the Department of the
19 County Clerk consistent with the rules and procedures for the maintenance and retention
20 of records as promulgated by the Secretary of State.

1 Section 4. This Ordinance shall be in full force and effect from and after its
2 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity
3 shall not affect the remainder of this Ordinance.


