





Amendment to Agreement

This Amendment to Agreement is effective as of December _____, 2015 and is made by and among Mercy Hospital Jefferson, a Missouri nonprofit corporation (the "Hospital"), the Jefferson County Department of Administrative Services (the "County"), and Mercy Health Services, LLC d/b/a Mercy Corporate Health ("Health").

WHEREAS, Health and the County are parties to that certain Occupational Health Services contract ("Contract"); and

WHEREAS, the County and Health have agreed to extend the term of the Contract for an additional year; and

WHEREAS, Health has requested that its affiliate, Hospital, be added as a party to the Contract and the County has agreed to the same.

NOW, THEREFORE, the parties agree:

1. Hospital, through its operating division known as Mercy Occupational Medicine – Festus, joins the Contract as a party.
2. The obligations and rights of Health under the Contract are now the joint and several obligations and rights of Health and Hospital.
3. The parties acknowledge that, as between Health and Hospital, Hospital will be the one primarily providing services and billing charges under the Contract.
