IV. Asphalt Striping

1. Spaces

- A. Parking lot striping to be laid out in such manner as to best utilize and maximize the parking locations with the minimum number indicated for each parking lot listed in section I. (This may be amended to incorporate disabled parking, but only to the degree necessary, and with written approval from the Director of Parks and Recreation.)
- B. The minimum distance of each normal parking space will be 9 foot wide, 18 foot long. Driving Isles will be 24 foot. The color of striping shall be white and adhere to MODOT regulations.
- C. Disabled parking will be positioned such as to be the most convenient access for the patron to the location / attraction of each parking lot. The color of which shall be blue and adhere to MODOT / ADA regulations including the use of the wheelchair symbol within the parking space. The number of parking spaces for ADA compliance are listed in section I.

V. Finish

1. Ensure all areas going from paved asphalt to a gravel walking path are level between the two surfaces.
2. Removal of any trash, residual asphalt, rock, dirt will be the responsibility of the contactor unless otherwise agreed in writing by the Director of Parks and Recreation or his designee.
3. All machinery, tools and property owned or rented for use by the contactor will be removed upon the project being finished.

b. The Top course will be Type BP-1 laid at a minimum of 2 inches after rolled compaction.
