2 Advanced SWAT Training Course at Hillsboro, Missouri, for the Jefferson County
3 Sheriff's Office and which were opened on August 23, 2016; and,

4 **WHEREAS**, the Jefferson County Sheriff's Office recommends that the bids be
5 rejected due to bids that were over the expected cost anticipated for the Advanced SWAT
6 Training Course; and

7 **WHEREAS**, the Jefferson County, Missouri, Council finds that it is in the best
8 interest of the County to reject the bids for the Rebid Advanced SWAT Training Course
9 for the Jefferson County Sheriff's Office and that said rejection shall be formally approval
10 by the County Council and County Executive.

3 shall not affect the remainder of this Ordinance.


