1 **AN ORDINANCE REJECTING ALL BIDS FOR THE RESPONSES TO**
2 **CERTAIN INVITATIONS FOR BID AND REQUESTS FOR PROPOSALS FOR**
3 **COUNTY JAIL SHOWER RENOVATIONS AT HILLSBORO, MISSOURI FOR**
4 **THE JEFFERSON COUNTY, DEPARTMENT OF PUBLIC WORKS.**

5 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") for the
6 Department of Public Works is seeking bids to remove and replace existing shower units,
7 piping, existing ceiling in shower room, new flooring and drains as indicated, new door,
8 frame and hardware indicated and patch existing wall, provide new exhaust fan, ductwork,
9 and devices and replacing piping in toilet chase; and,

10 **WHEREAS**, in response to certain Invitations for Bid and Requests for Proposals
11 for said training issued by the County, the County received bids and proposals for the

3 **WHEREAS**, the Jefferson County, Department of Public Works recommends that
4 the bids be rejected due to lack of information being provided to bidders on the Jail security
5 requirements; and

6 **WHEREAS**, the Jefferson County, Missouri, Council finds that it is in the best
7 interest of the County to reject the bids for the County Jail Shower Renovations for the
8 Jefferson County, Department of Public Works and that said rejection shall be formally
9 approved by the County Council and County Executive.

10 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,**




