3           **WHEREAS**, the Jefferson County, Department of the Sheriff recommends that the  
4       bids be rejected due to exceeded anticipated costs for the advanced SWAT training for the  
5       S.E.R.T. team; and

6           **WHEREAS**, the Jefferson County, Missouri, Council finds that it is in the best  
7       interest of the County to reject the bids for the Revised Rebid Advanced Swat Training  
8       Course for the Jefferson County, Department of the Sheriff and that said rejection shall be  
9       formally approval by the County Council and County Executive.


