1 **AN ORDINANCE RENEWING THE PROFESSIONAL SERVICE**
2 **AGREEMENTS FOR ON-CALL ROADWAY DESIGN SERVICES FOR 2016,**
3 **DEPARTMENT OF PUBLIC WORKS.**

4 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") recommends
5 the renewal of the following professional service agreements for various Department of
6 Public Works projects for the year 2016 and wishes to renew the agreements at the same
7 terms and conditions, as authorized by the County, for an additional one-year term:

2 budgetary limitations.

3 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI,**
4 **COUNCIL, AS FOLLOWS:**

5 Section 1. The County authorizes the renewal of the professional service
6 agreements for an additional one-year term as follows:

10 1-1-16 to 12-31-16

11 AMOUNT

12 Up to **\$250,000.00** total contract limit per firm

13 Subject to budgetary limitations.

18 Section 2. The Jefferson County, Missouri, Council hereby authorizes the
19 County Executive to execute a renewal agreement, incorporated herein by reference and
20 attached as Exhibit A1 though A3. The County Executive is further authorized to take
21 any and all actions necessary to carry out the intent of this Ordinance.

1 Section 3. Copies of all Invitations for Bid, Requests for Proposals, responses
2 thereto, and any contracts or agreements shall be maintained by the Department of the
3 County Clerk consistent with the rules and procedures for the maintenance and retention
4 of records as promulgated by the Secretary of State.

5 Section 4. This Ordinance shall be in full force and effect from and after its
6 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity
7 shall not affect the remainder of this Ordinance.
