5 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") for the
6 Department of Parks and Recreation is seeking asphalt project for resurfacing with sealing
7 and restriping for the High Ridge Civic Center parking lot; and,

1 **WHEREAS**, the Jefferson County, Department of Parks and Recreation
2 recommends that the bids be rejected due to a change of scope due to several bids that came
3 back under the amount to be spent for the High Ridge Civic Center Asphalt Project; and

4 **WHEREAS**, the Jefferson County, Department of Parks and Recreation has
5 requested Federal Emergency Management Agency (FEMA) change the size of the project
6 scope and an extension to increase the time necessary to complete the project; and

7 **WHEREAS**, the Jefferson County, Missouri, Council finds that it is in the best
8 interest of the County to reject the bids for the High Ridge Civic Center Asphalt Project
9 for the Department of Parks and Recreation and that said rejection shall be formally
10 approved by the County Council and County Executive.

11 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,**
12 **AS FOLLOWS:**

13 Section 1. The County rejects the following bids and proposals which are
14 incorporated by this reference as if fully set out herein:

18 Rejection upon approval by the County Council and County Executive

19 Section 2. The County rejects the bid as recommended by the Department of
20 Parks and Recreation due to change of scope necessary to change the size of the project
21 and an extension to increase the time necessary to complete the project for the High Ridge
22 Civic Center Asphalt Project.

1 Section 3. This Ordinance shall be in full force and effect from and after its
2 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity
3 shall not affect the remainder of this Ordinance.






