4 **COUNTY, DEPARTMENT OF PUBLIC WORKS.**

5 **WHEREAS**, Jefferson County, Missouri, (hereafter, the "County") for the
6 Department of Public Works is seeking guardrail material for County use, based on pickup

1 **WHEREAS**, Jefferson County, Missouri, Ordinance 17-0240 was approved to
2 grant a three (3) month extension of the current contract for Guard Rail, Posts and
3 Accessories 2015 with D & S Fencing, Inc. and Collins & Herman, Inc. for the Jefferson
4 County, Department of Public Works; and,

5 **WHEREAS**, the Jefferson County, Department of Public Works recommends that
6 the bids be rejected due to the approved three-month extension and the revision of new bid
7 specifications; and

8 **WHEREAS**, the Jefferson County, Missouri, Council finds that it is in the best
9 interest of the County to reject the bids for the Guard Rail, Posts and Accessories 2017 for
10 the Jefferson County, Department of Public Works and that said rejection shall be formally
11 approved by the County Council and County Executive.

22 Guard Rail, Posts, and Accessories.


1 **Section 3.** This Ordinance shall be in full force and effect from and after its






