1 **WHEREAS**, the Department of Public Works, Division of Fleet Services of
2 Jefferson County, Missouri, finds it is in the best interest of the County to renew the bid
3 award for Vehicle Equipment and Lighting Installation for the term of 7-25-17 to 7-24-18
4 with Lowe Automotive Wholesale Inc. with approval of the County Council and County
5 Executive up to **\$10,000.00 per year, for total amount not to exceed \$10,000.00**
6 **annually**, subject to budgetary limitations.

7 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,**

9 Section 1. The County authorizes the renewal of the bid awards for an

1 Section 2. The Jefferson County, Missouri, Council hereby authorizes the
2 County Executive to execute a renewal agreement, incorporated herein by reference and
3 attached as Exhibit A. The County Executive is further authorized to take any and all
4 actions necessary to carry out the intent of this Ordinance.

5 Section 3. Copies of all Invitations for Bid, Requests for Proposals, responses
6 thereto, and any contracts or agreements shall be maintained by the Department of the
7 County Clerk consistent with the rules and procedures for the maintenance and retention
8 of records as promulgated by the Secretary of State.

9 Section 4. This Ordinance shall be in full force and effect from and after its
10 date of approval. If any part of this Ordinance is invalid for any reason, such invalidity
11 shall not affect the remainder of this Ordinance.
