6' Tall Chain Link Fence:

To furnish and install (370') of 6' tall, 9 gauge, 2" mesh, galvanized chain link fence with 2-7/8" SS40 terminal post, 2-3/8"SS40 line post, 1-5/8" SS40 top rail, 1-5/8" SS40 brace rail at all end / corner / gate post, 3/8" truss rods with tighteners at all end / corner / gate post, and 7 gauge tension wire at bottom of fence. Furnish and install (1) 6' tall x 12' wide double drive gate hung on 2-7/8" SS40 post with bulldog hinges. Gate to have a commercial drop rod.

6' Solid Privacy White Vinyl Fence:

To furnish and install (44') of 6' tall x 8' wide, solid privacy, white vinyl fence with 5"x5" post, 1-3/4"x5-1/2" rails, and 7/8"x6" pickets. Furnish and install (2) 6' tall x 12' wide double drive gate. Gate post to have aluminum inserts. Gates to have standard hinges with drop canes on each leaf.

Cantilever Gate:

To furnish and install (1) 6' tall x 24' wide (opening) cantilever gate hung on 4" SS40 post with nylon rollers. Gate to have 2-7/8" latch post and gate receiver.

Cantilever Gate Operator and Access Controls:

To furnish and (1) CSL24u LiftMaster operator, (2) aluminum gate edges with receivers and transmitters, (1) AK11 keypad, (1) goose neck for the key pad, (1) post mount for the operator, (1) photoeye, (1) 3502 knox box key witch, and free exit and safety loops. Electric and conduit by others.

All post set in 3,000psi concrete

All PUBLIC utilities to be located/marked by Consolidated Fence prior to fence installation.

2. Cost of Bonds. Add 3% for Bond.
3. Supply, installation of rental or temporary construction fence.
4. Removal of spoils, clearing, grading, grubbing, survey, and staking of fence line.
5. Private underground utility repairs and locates, including irrigation systems.
6. Door hardware, locks and installation.
7. Saw cutting and core drilling.
8. Fence grounding and electrical both high and low voltage, conduit runs, wire pulls.
9. Back ground checks and/or finger printing.

Buyer shall provide at no cost, the following:

1. All weather truck and equipment access for material delivery and installation during project.

6. Special order materials require payment in full before shipping (Greenscreen, Omega, Ameristar, wrought iron and door hardware)
7. This proposal is based on normal digging conditions (price subject to change if unforeseen rock and fill material is encountered).
8. Material on hand payment required on all jobs over \$15,000.00.
9. No change orders will be accepted nor will any material be ordered unless written consent has been made.
