1 for the term of 1-1-19 to 12-31-19 with Clean Uniform with approval of the County Council  
2 and County Executive up to **\$27,500.00 per term, for total amount not to exceed**  
3 **\$27,500.00 for the term**, subject to budgetary limitations; and

4 **WHEREAS**, the contract for the Rebid –Uniforms 2015 contains two separate  
5 provisions regarding renewal; and

6 **WHEREAS**, there is some inconsistency between the two provisions; and

7 **WHEREAS**, to the clarify the renewal terms the County desires to enter into an  
8 Addendum Agreement to the Rebid –Uniforms 2015 Contract with Clean Uniform which  
9 clarifies the inconsistency in the Rebid –Uniforms 2015 Contract.

10 **BE IT ENACTED BY THE JEFFERSON COUNTY, MISSOURI, COUNCIL,**  
11 **AS FOLLOWS:**

12 Section 1. The County authorizes the renewal of the bid awards for an  
13 additional one-year term as follows:

4 Section 2. The Jefferson County, Missouri, Council hereby authorizes the  
5 County Executive to execute a renewal agreement, attached hereto as Exhibit A and  
6 incorporated herein by reference. The County Executive is further authorized to take any  
7 and all actions necessary to carry out the intent of this Ordinance.

8 Section 3. The Jefferson County, Missouri, Council hereby authorizes the  
9 County Executive to execute the Addendum Agreement, attached hereto as Exhibit B and  
10 incorporated herein by reference.

11 Section 4. Copies of all Invitations for Bid, Requests for Proposals, responses  
12 thereto, and any contracts or agreements shall be maintained by the Department of the  
13 County Clerk consistent with the rules and procedures for the maintenance and retention  
14 of records as promulgated by the Secretary of State.


15 Section 5. This Ordinance shall be in full force and effect from and after its

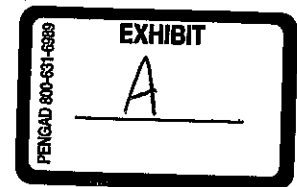

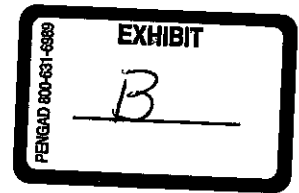

# ADDENDUM AGREEMENT TO REBID-UNIFORMS 2015 CONTRACT

This Addendum Agreement to the Rebid-Uniforms 2015 Contract is entered into by and between Jefferson County, Missouri (hereinafter the "County") and Clean Uniform company (hereinafter "Clean Uniform") as of the date last written below.

WHEREAS, On November 24, 2015 the County enacted Ordinance Number 15-0601 (hereinafter the "Ordinance"); and

WHEREAS, the Ordinance awarded a bid for services to Clean Uniform, specifically pursuant to a Request for Proposal known as the Rebid-Uniforms 2015 Contract (hereinafter the "Contract") which was attached to the Ordinance and incorporated therein via reference; and

WHEREAS, the Contract is for a term of three years; and

WHEREAS, the Contract contains two separate provisions providing for renewal at the end of the initial term; and

WHEREAS, the two separate renewal provisions in the Contract are inconsistent; and

WHEREAS, the parties recognize the inconsistency and to resolve the inconsistency desire to enter into this Agreement resolving the inconsistency; and

WHEREAS, the parties recognize the mutual advantages gained in having a clear Contract and enter into this Agreement to gain those advantages.

NOW THEREFORE, IN CONSIDERATION OF THE PREMISES, THE PARTIES AGREE AS FOLLOWS:

1. The terms of the Contract, on page 1 of said document, providing that:

*"The County has the option to renew this agreement at the same terms and conditions as the original agreement for two additional one-year terms with the written consent of the successful Bidder."*

shall prevail over any inconsistency in the provisions of the Contract set forth on page 8 of said document providing that the:


*"County reserves the right to negotiate the contract for one (1) additional one-year term with the written consent of the awarded vendor."*
