10 County Clerk consistent with the rules and procedures for the maintenance and retention
11 of records as promulgated by the Secretary of State.


12 Section 4. This Ordinance shall be in full force and effect from and after its

REQUEST: As part of the 2013 Master Services Agreement (MSA), between Jefferson County, MO and REJIS Commission, this agreement is to enact the renewal options provided for in the aforementioned MSA for a period of 24 months. The terms of the agreement shall remain unchanged and the rate structure will follow a revised index adjustment of 2% annually to the contract base. On January 1, 2019, the base contract fee will be \$1,370,755 plus monthly and annual fees and will be adjusted to \$1,398,170 on January 1, 2020.

ACKNOWLEDGEMENT OF TERMS & CONDITIONS

The parties hereto affirm each has full knowledge of the terms, covenants, conditions, warranties, and requirements contained in this change order. Each party acknowledges that such party, after negotiation and consultation, has reviewed and revised this Agreement. As such, the terms of this Agreement shall be fairly construed and the usual rule of construction, to the effect that any ambiguities herein should be resolved against the drafting party, shall not be employed in the interpretation of this Agreement or any amendments, modifications or exhibits thereto.
