Election Security Cage Specifications **Jefferson County, Missouri**

The Jefferson County Clerk is interested in purchasing approximately 53 to 60 mobile security cages to house voting tabulation equipment, ballot box, ballots, and poll supplies for the 53 polling places.

The minimum specifications are as follows:

Dimensions: (Range)

- 33" – 35" Width
- 52" – 55" Length
- 68" – 70" Height

Shelves:

- Must include top and bottom shelves.
- Shelves must be rated at a minimum of 200 lbs.
- Shelves must be adjustable at 1" increments.

(proposed: 2" increments)

Castors:

- Must be equipped with (4) polyurethane castors. At least two (2) castors must include 5MBPB with brakes and two (2) 5MP.
- Castors must be rated at a minimum of 900 lbs.

Cage requirements:

- Must include bumper guards, one for each wheel to protect doorways and doors.
- The cages must be of heavy gauge open wire construction, at least 1/4" wire steel, chrome coated.
- Cages must provide 270-degree double door entry, that can be secured along the sides of the units.
- Door handle must provide at least a 1/4" turn and provide with a security mechanism for zip tie/pad lock.

(proposed: 3/16" wire steel, powder-coated paint)

Delivery:

- Include all shipping and handling charges.
- Include an estimated time needed for fulfilling order once bid is approved.

Other:

- Provide any other available features or accessories.
- Provide any warranties and financing details available.
- Bid is to reflect a cost per unit.
