

OWNER RESPONSES TO REQUESTS FOR INFORMATION/INTERPRETATION

1. CUSTOM BUILT CABINETS & COUNTERTOPS: Follow Bid Specifications (06 4116 & 12 3623) requiring:
 1. AWI Quality Certification Program certificates or WI Certified Compliance Program certificates of fabricator; and
 2. Fabricator to install all units.
2. MEDICAL GAS PIPING: This item is not included in the plans or spec's, and is not to be included in the base bids. This scope of work will be clarified and detailed after contract award and negotiated with the selected Contractor.
3. FIRE & SMOKE ALARMS to be provided by Owner's separate contractor. Fire Sprinkler system Designer and Installer to coordinate with Owner's Alarm & Detection Contractor for a fully compatible, code compliant Fire Alarm and Auto Fire Suppression system.
4. ROOM IDENTIFICATION SIGNS identified in specs section 10 1423 are to be provided and installed by the Owner, under a separate contract. Do not include this room signage in the base bid.
5. STRUCTURAL DESIGN OF COLD FORMED STEEL:
 1. Structural Engineer's plans (S1.0, notes 2 & 3) indicate that un-detailed connections are to be calculateddesigned by the fabricator's engineer.
 2. In the case of discrepancies between the specifications and the plans, the Structural Engineer's drawings & notes shall govern.
 3. Separate Engineer's design & calculations are not required for items specified/included in the Structural Engineer's plans, only those un-detailed connections referenced above.
6. GENERAL ELECTRICAL QUESTIONS:
 1. Assume existing Ameren Transformer will remain and will provide power for the new facility.
 2. Power to existing well/pump, sanitation lift station and parking lot lighting to remain. Include only additional wiring necessary if the new panel locations require it to re-connect these items.
 3. Electrical panels to be located in Room 184.

4. Provide all new electrical panels.
5. Base bid to include all wiring in rigid metal conduit or electrical metallic tubing per spec's section 16130 1.0. MC cable is not acceptable per Section 16120.
6. All new electrical panels are to be fed by the existing electrical service.

7. ASPHALT OVERLAY detail on sheet C 5.0 is not applicable to this project.

8. GLAZING SPEC'S:

1. Hollow Metal Interior units: 1/4" tempered, clear float glass (see plan details)
2. Exterior aluminum windows and storefront units:
 1. Glazing method shall be in general accordance with the FGMA Glazing Manual for specified glass type, or as approved by the glass fabricator.

Shall consist of steel hinge plates welded to .18-inch (5mm) diameter vertical steel rods, with a single row of plates at the bottom and top with intermediate rows at approximately 42-inch (1067mm) on center. Partitions 10'-0" (3048mm) high or over have a double row of hinge plates at the top. A high tensile alloy steel trolley yoke, functioning as a hinge pin at required intervals, supports the frame assembly.
4. Partition Trim: Exposed sweep strips of one consistent color.
5. SOUND SEALS Shall be pairs of three-layer flexible sweep strips at top and bottom. Vertical Female sound channel shall be polyurethane foam lined.

7. Pairs of Flexible Sweep Strips: Shall be provided at top and bottom of the partition. Air release for air trapped within the folding partition shall be accomplished during operation by a series of 3/8-inch (9.5mm) diameter holes through the lead post molding.
8. **HARDWARE**
 1. Grip type hand pulls shall be die cast zinc, satin chrome finish. Extruded aluminum or plastic hand pulls will not be accepted.
9. **SUSPENSION SYSTEM**
 1. #6 or #7 Suspension System, track and trolley sizes matched to the size of the partition.
