I am available 24 hours a day for emergency. Currently all the handlers know how to get a hold of me if the need to for an emergency. I am unable to give prices for emergencies, as I do not know the nature of the event and cannot see what would need to be done.

The dog food that we provide for the K-9's is specially designed for their continued health. I have a long history of keeping the dogs on the street and not sick. They miss very few days of street duty. I attribute that directly to good nutrition. The food prices will change, as they change on me at frequent intervals. I am sorry for this, but it is out of my control.

EQUIPMENT:

The first aid kit is supplied and restocked as necessary. For a new dog to be supplied with the kit it will be \$50.00/dog. Some of the products listed on your first aid kit are no longer available. The disinfectant for kennel sanitization will be whatever the product is selling for at the time of purchase, as these products change in cost. I will not mark them up. Currently they are running about \$50 to \$70 per gallon for name brand. Generics are about \$30 to \$40 per gallon.
